Regional Transportation Improvement Program (RTIP)

Senior Planner & Transportation Modeler Theressa Julius reviewed the draft 2024-2027 Regional Transportation Improvement Program (RTIP). The RTIP is updated annually and includes federally funded, state-sponsored, and regionally significant projects that need to be included in the State's Transportation Improvement Program (STIP). The draft RTIP is currently out for public review.

Staff is requesting TPB make a recommendation for Council to adopt the RTIP at the Council's October meeting.

Board member O'Callahan moved, seconded by Board member Melnick, to recommend the Council adopt the 2024-2027 Regional Transportation Improvement Program. Motion carried.

Agenda Item 7 ACTION

Regional Trails Plan Draft Review

Transportation Manager, Katrina Van Every, and Senior Planner, Paul Brewster provided an overview of the draft Regional Trails Plan Update and requested the Policy Board release the draft for public review.

Staff identified five goals for the regional trails network:

- A connected and accessible network.
- A user-friendly network.
- A safe and secure experience.
- A collaborative effort.
- A well-maintained network.

Adopting and updating the regional trails plan gives staff the opportunity to assess conditions and talk to the community about how they use the system, gathering their views on future investments in expansion, maintenance, enhancements, and operations.

To support this, the plan calls for TRPC to commit to three things:

- Establishing a regional trails planning workgroup.
- · Convening an annual regional trail meeting.
- Updating the Plan every five years.

Staff requested that the Policy Board release the Thurston Regional Trails Plan for public review and comment.

Board member Madrone moved, seconded by Board member Melnick to direct staff to come up with a recommendation for the Policy Board to consider for their next meeting, which would then go to Council for approval, to create a federal funding set-aside for coordination of a subcommittee/advisory group and regional trail maintenance and preservation. Motion carried.

SUBJECT: 5-Year Update to the Regional Transportation Plan

PURPOSE

Staff will provide an overview of the forthcoming Regional Transportation Plan (RTP) update.

Summary:

- The Regional Transportation Plan (RTP) is due to be updated in 2025. The RTP fulfills both state and federal requirements for transportation planning at the regional level.
- Since 2020, the Thurston region has seen changes affecting how and when people travel, primarily due to the COVID-19 pandemic, and completed a lot of work.
- In 2023, the Thurston Region was designated a Transportation Management Area (TMA) due to the region's increase in population. This designation comes with a small increase in transportation funding and additional responsibilities, including establishing a Congestion Management Process.
- Since 2020, Thurston Regional Planning Council (TRPC) has also performed a lot of planning work that will inform this RTP update.
- To address the changes in our Region and the work that has occurred in the last five years, staff is concentrating this update on:
 - Incorporating new information from the work we've accomplished since 2016, including but not limited to climate change planning, the transportation priorities survey results and equity work, and new TMA responsibilities.
 - General housekeeping tasks, including updating the project list, the financial forecast, and correcting typos where appropriate.
- Throughout the update process, staff proposes periodically presenting to TPB information on equity, climate change, regional project list, financial forecast, and 2050 travel demand as they relate to the RTP.

EQUITY CONSIDERATIONS

The Regional Transportation Plan (RTP) helps identify the key components of the region's multimodal transportation system that connects people to important destinations and improves access to goods and services, which benefits underserved communities. Areas of the RTP that address equity directly include:

- **Demographics.** The RTP includes a one-page equity infographic about the Thurston Region, identifying statistics on racial diversity, access to cars, cost-burdened households, veterans, linguistic isolation, and other demographics. Seep Chapter 1, page 22.
- Regional Multimodal Projects. Projects included in the RTP that will be constructed in the next five
 years include the Fones Road Improvements and the Martin Way Park & Ride Direct Access for Transit
 project. Each of these projects improve multimodal service for burdened populations by building
 sidewalks, bike lanes, or improving bus service. See Chapter 2 and Appendix L.
- Goals and Policies. The goals and policies of the RTP establish a framework for ensuring our
 transportation system offers safe, efficient, and affordable multimodal transportation options. This
 includes ensuring barrier-free transportation investments that support the special travel needs of youth,
 elders, and other burdened populations, providing a robust level of reliable and effective public
 transportation options. See Chapter 3.

As part of this RTP update, staff will be incorporating into the RTP the work TRPC has completed to date regarding diversity, equity, inclusion, belonging, and environmental justice.

BACKGROUND

The RTP serves many functions – from implementing local plans (such as Sustainable Thurston) to balancing social, financial, and environmental costs and impacts, to acknowledging the diversity of transportation needs in our region. The RTP fulfills both state and federal requirements for transportation planning at the regional level and sets the stage for how federal funding is used to support project delivery at the local level (Call for Projects process).

The Regional Transportation Plan is required to be updated every five years; the last update occurred in 2020 with a subsequent amendment in 2022/2023. The update must comply with state/federal laws and include the following elements:

- Outreach Component. For this RTP update, we will use the 2021 Transportation Priorities Survey (conducted countywide) as the basis for our outreach to the community. The information from the survey is still relevant and will. Additionally, we are required to hold at least a two-week public comment period on the draft plan before Council considers adoption in 2025.
- **Future Travel Demand.** TRPC's modeling team is in the midst of updating the regional travel demand models, which help us identify areas in the region that we can expect to have regional mobility issues in the future. They also help us understand whether the projects planned during the planning horizon will address the issues identified.
- **20-Year Planning Horizon.** The RTP is required to cover a period of at least 20 years; TRPC typically plans for a 25-year horizon.
- **Updated Project List.** The project list includes projects that have regional significance for travel in the Thurston Region. It also includes planning projects that set the basis for future regional construction/implementation projects.
- **Updated Financial Forecast.** The financial forecast is based on the sources of transportation funding and the projects proposed to be completed during the forecast period.

ISSUES

TMA Transition. In 2023, the Thurston Region was designated a Transportation Management Area (TMA) due to the region's increase in population. This designation comes with a small increase in transportation funding and additional responsibilities, including establishing a congestion management process (CMP) which is due by the end of 2024. This effort is being treated as a separate work item from the RTP, but the resulting process will be rolled into the RTP as an appendix. The TPB can expect to hear more about this in the coming months.

Incorporate planning work into the RTP. Since 2020, TRPC has performed a lot of planning work that can inform this update of the RTP. This work includes climate change planning, the countywide transportation priorities survey conducted in 2021, the household travel survey conducted in 2022, the updated the Call for Projects process, and the updated Thurston Regional Trails Plan, which is expected to be complete by the end of the year.

Since

TPB Reviews. Staff proposes presenting the following topics to TPB throughout the update process:

- 1. **Equity.** Over the last five years, TRPC has done a lot of work considering how we talk about, address, and measure equity. The RTP will be updated to incorporate this work, including the results from the 2021 countywide Transportation Priorities Survey.
- Climate Change. Since 2016, TRPC has completed climate adaptation and climate mitigation plans for the Thurston Region, supported the functioning and formation of the Thurston Climate Action Steering Committee, and created a Thurston Climate Action Dashboard. Attention now needs to be given to the specific actions TRPC can embed in its work.
- 3. **Project List.** The project list represents the majority of the RTP's recommendations. Staff will work with Thurston County, the town and cities in Thurston County, the Tribes, Washington State Department of Transportation, and Intercity Transit to update this list.
- 4. **Future Conditions.** The future conditions will lay out what future transportation patterns may be in 2050, including progress towards meeting our vehicle miles traveled (VMT) reduction goals.
- 5. **Financial Forecast**. The RTP is required to be a financially constrained plan meaning only projects for which funding can reasonably be assumed to be available can be included in the plan.
